We are pleased to serve you and your patients at PENRAD Imaging. We continue to offer the full range of medical imaging services to assist you in the diagnosis and management of your patients. We are now expanding our patient navigator program by helping to facilitate the referral process when a patient is in need of breast surgery or other breast treatment services. This new program also has the potential to make you and your office staff more efficient by decreasing the demands for communication and coordination of services.

In expanding our program to include the referral process, we want to honor the desires of our individual referring providers. Those who would like to participate in this expanded service may elect to do so, while those who prefer the traditional process of making their own referrals when the need arises can continue in that manner.
